Impact of the Infant Formula Recall

On February 17, 2022, a facility manufacturing powdered infant formula in Michigan issued a recall of formula suspected to be infected with the *Cronobacter sakazakii* bacteria. As one of only three major formula producers in the United States, this facility shutdown, compounded by the worldwide supply-chain crisis, contributed to a severe shortage of infant formula in the U.S.

Like its causes, the consequences of this shortage are complex and far-reaching. Join host Jannah Amiel, MS, BSN, RN and guest Steven Abrams, MD as they explore what went wrong, how the government responded, and how the shortage has impacted infant nutrition across the country.


